# **Board President Message**

This past year has been full of success stories for the Women's Resource Center putting the organization in a great position for the future.

The biggest news, years in the making, was reaching the Capital Campaign goal of two and a half million dollars. This major undertaking was achieved during a global pandemic! The success of the campaign truly shows the support of the community in our mission to provide the life-saving and life-changing services to thousands of survivors every year. The funds raised will be used for our Safe Housing Program, the Barbara J. Hart Justice Center, our Teen and Young Adult Programs, and much needed facility improvements. Many thanks go out to our Campaign co-chairs, David and Ann Hawk, along with the community leaders and board members that have taken their time to help the Women's Resource Center with this endeavor.

A portion of the funds raised during the capital campaign were invested into the first ever endowment fund. An endowment helps ensure the future of WRC and gives our participants and their families a life free of violence and filled with hope. It is intended to be invested for at least ten years without any withdrawals.

WRC completed a six-month Strategic Planning Assessment in June, including steps to reach each of the goals over the next three years. Some of the goals have already been reached and implemented.

One of the unforeseen challenges was unexpected delays in approved funding from two major sources, which put all organizations like ours in a challenging place. Sadly, this resulted in some of these organizations being unable to take on new clients for a period of time, but thanks to some strategic positioning and planning from previous years, WRC was able to mitigate the financial headwinds while keeping the doors open and serving new clients.

Another key accomplishment is the growth of our Safe Dates & Healthy Relationships programs in the local schools and medical advocacy program. We are not only providing services to those in immediate need but creating resources to identify and stop violence before it starts.

One final thought for your consideration... It is common for many non-for-profit organizations who help others to have clients that are outspoken about their cause or the organization that provided the help they needed. This yields constant awareness among the public. However, WRC clients aren't likely to be outspoken about their experience simply due to the nature of their circumstance. The result is the public at large doesn't realize just how many people WRC has helped. It could be our own family members, or friends, or coworkers and we might not even know. Please keep this in mind because we are so fortunate to have an organization as ready and able as the Women's Resource Center in our community.

I would like to thank the dedicated staff of the Women's Resource Center who continue to assist victims of domestic violence year after year. The staff, led by Executive Director, Peg Ruddy, continue their work of advocacy, education, and social change in our community.

Thank you to the Board of Directors, the Association, the Campaign Committee and of course, the dedicated staff and many volunteers that help to make us a success.

# **About Women's Resource Center**



Our primary purpose at the Women's Resource Center is to protect families from the immediate danger stemming from domestic and sexual violence and to break the inter-generational cycle of abuse. All of our programs are designed with this purpose in mind. We help survivors to have safe, healthy relationships and how to remain safe.

Our services are available to all survivors of domestic violence and sexual assault



Trained advocates answer our English and Spanish hotline 24 hours a day, seven days a week.



We offer emergency shelter, counseling, legal support and advocacy, and in some cases, legal representation.



WRC community educators offer programs to raise awareness, and to prevent domestic and sexual violence.



# **WRC Counseling Services**

WRC offers trauma informed supportive counseling for our adult and child survivors of domestic and sexual abuse. We provide connections to supportive community resources and help survivors create a personal Safety Plan. Individual counseling is available and our advocates help survivors engage in solution-focused strategies to achieve their self-determined goals and objectives. All our services are available in all languages. WRC provides counseling for child victims of domestic violence and/or sexual assault. Our Survivors Support Groups focus on mindfulness, emotions, relationships, coping, support from peers, and skill-building.



# **Safe Housing**

The Women's Resource Center is a safe place and employs a "housing first model." This means providing emergency safe housing for those women, children, and men who must flee their homes to be safe. Longer term housing options are available to assist survivors to secure a life free from violence and oppression. From emergency housing, participants are provided transitional or rapid re-housing, and are given financial assistance for a security deposit, rent, utilities, furnishings, food, and funds for transportation. Advocates continue to work closely with them to find employment and eventually a permanent, affordable home of their own.



WRC provided emergency safe housing for 138 adults and 97 children. The Safe Nights program provided 18,339 nights of safe shelter to 48 families fleeing from domestic and/or sexual violence.

# **Emergency Crisis Program**

The hotline serves as a point of access for crisis counseling, safety planning, resources, referrals, and intake to the Women's Resource Center's Safe House for survivors of domestic violence and sexual assault. Available 24/7. our Advocates provide one-on-one assistance and 3 address rape, child sexual abuse, incest, stalking, human trafficking, economic abuse, teen dating violence, emotional and verbal abuse, physical assault, and threats of harm.



In 2021, more than 11.452 calls are received on the WRC crisis hotline. This is the highest number of hotline calls WRC has ever received in one year!

## Barbara J. Hart Justice Center

Through the Barbara J. Hart Justice Center, WRC utilizes the combined skills of dedicated attorneys and advocates to provide legal assistance to program participants. The Justice Center's areas of representation include; legal representation and consultation, Protection from Abuse (PFA) and Sexual Violence Protection Orders (SVPO), child custody, child support, spousal support, divorce, housing matters, consumer debt, and immigration issues. We also provide education/training to other attorneys and professionals. Six out of ten WRC program participants require legal assistance. Currently, the Justice Center serves over 100 clients per year and there is a waiting list.

Without the Barbra J Heart Justice Center, I would have never been able to afford representation. Also, I would have had to face my abuser in person and speak to him directly every time he took me into court. I also felt safe and secure knowing Juliana, my attorney, was going to be there by my side and is also a phone call away EVERYTIME my abuser was acting out and the cops were no help to myself or my children. I don't know if I could have fought the custody, PFA'S against me and also his violations on my own. Not to mention domestic relations. I cannot thank the WRC and Barbara J Heart Justice Center enough.

# **WRC Susquehanna County Office News**

WRC's array of housing programs and resources continues grow in Susquehanna County. WRC is aware that survivors living in rural communities often encounter extra barriers. Lack of access to their own vehicles or public transportation, inconsistent cellular and limited internet services can all make it a challenge for someone to access domestic and sexual violence services in a safe manner.

Survivors benefit from housing search, rental assistance and case management support that assists them in identifying goals and resources that will support economic stability and independence, as well as continuing to address their individual safety and legal needs. The Susquehanna County office alone provided services to 270 survivors of domestic violence and 93 survivors of sexual assault during the 2021-2022 fiscal year.

The team continues to focus on building partnerships with community agencies and resources. WRC set up resource tables at events throughout the community, including back to school and parent-teacher nights at many of the county's public schools, National Night Out, the New Milford Midtown Festival, the Blueberry Festival and the Susquehanna County Health, Wellness and Safety Day.



The Endless Mountains Learning Center raised funds for WRC and was able to donate \$2,060 and 9 Knowledge Crates that were distributed to survivors with young children.

The prevention and education program in Susquehanna County have been busy expanding connections with school districts and other youth serving organizations. Teen Counselor Advocate Andrew Granick has several school districts interested in scheduling to have the Safe Dates program offered to students during the 2022/2023 academic year.





In October, WRC raised community awareness about domestic violence by placing purple ribbons on the Green next to the Susquehanna courthouse for Domestic Violence Awareness Month. In the April of 2022, Erie and Main Coffeehouse in Susquehanna PA used coffee sleeves that spread awareness regarding sexual assault during Sexual Assault Awareness Month.

# **Teen & Young Adult Educational Programs**




Essential to diminishing, and ultimately eliminating, domestic violence and sexual abuse, WRC is committed to educating local youth and teens about healthy relationships to help them understand how to prevent dating violence and sexual assault. Often teen dating can lead to physical assault, stalking, and sexual abuse, with consequences for the victims, their families, friends, schools and communities. WRC provides in-school educational programming to students in grades 7-12 in the school districts across Lackawanna and Susquehanna counties. Currently we have three full-time educators to provide these services. Additionally, WRC advocates go into the schools to work confidentially with individual young victims of domestic violence or sexual abuse.

WRC Prevention Education staff also developed a Trauma-Informed Schools Training for school professionals such as principals, teachers, administrators, and counselors. Trauma affects youth in all communities, and responses to those experiences by youth-serving systems are critical. This training also addresses selfcare. WRC will work with each school to develop in-service training to meet their current needs.

Safe Dates for grades 8-12 was held in the following school districts this year: Old Forge, Mid Valley, West Scranton, Scranton, Abington Heights, Lakeland, OLP, St Paul's, St Mary's, Nativity Miguel, All Saint's Academy

Healthy Teen Relationships (HTRP) for grades 6-7: Lakeland, OLP, St Paul's, St Mary's, Nativity Miguel, All Saint's Academy. This was the first year for this program and we piloted elementary aged curriculum in grades 3-5 at one school in addition to the HTRP in 6-7 grades.





# **Medical Advocacy Program at the WRC**

The Women's Resource's Medical Advocacy Program (MAP) continues to expand our presence in Lackawanna and Susquehanna counties. Medical Advocacy includes the healthcare-based identification of domestic violence, sexual assault & human trafficking victims within the healthcare setting. This program includes developing and implementing policies and procedures to enhance the health care response to these victims at various medical practices & institutions. WRC establishes relationships with health care systems to better serve patients and healthcare professionals alike. Trainings provided by our MAP team are at no cost and cover a variety of issues related to Domestic Violence, Sexual Assault and Human Trafficking.





MAP has provided training to 300+ Medical Professionals in various fields. Through support from the AllOne Foundation, WRC has been able to collaborate with VIP, the domestic and sexual assault crisis program serving Wayne & Pike Counties. This effort led to nine registered nurses being trained as Sexual Assault Nurse Examiners (SANE) nurses, able to provide forensic rape exams.

## **WRC Pet Program**

Often survivors are forced to decide between leaving their pets behind or staying to protect them. It is estimated that 65% of victims stay in abusive relationships for the safety of their pets. The availability of supplies and access to kenneling enable survivors to be able to leave an abusive relationship. Many times, a pet can be a major source of comfort to a survivor and their family. It's important WRC has resources to bring their pets to help during an extremely difficult time

WRC has safe housed at least 5 pets including cats/dogs. Provided veterinary services for 7 dogs, 5 cats, and 1 ferret. Not to mention, supplied pet food and cat litter, litter pans, litter scoopers, and food bowls for several pets. WRC Help posters are also placed in local veterinary clinics throughout Lackawanna and Susquehanna Counties.




