EMERGENCY CRISIS PROGRAM

WRC's 24/7 Emergency Crisis Hotline connects survivors to crisis counseling, safety planning, resources, and WRC's Safe House. Advocates provide one-on-one support for issues including domestic violence, sexual assault, child abuse, stalking, human trafficking, and more.

SAFE NIGHTS OF SHELTER

WRC provides a safe haven through its "housing first" model, offering emergency shelter for those fleeing violence. Survivors receive support to transition into stable housing with assistance for rent, utilities, food, and transportation. Advocates help them secure employment and work toward a permanent, affordable home, fostering a life free from violence and oppression.



WRC COUNSELING SERVICES

WRC provides trauma-informed counseling for adult and child survivors of domestic and sexual abuse. Services include personal safety plans, individual counseling, and connections to community resources. Advocates guide survivors toward self-determined goals, and support groups focus on mindfulness, relationships, coping, and skill-building.

TEEN & YOUNG ADULT PROGRAMS

WRC's youth programs educate teens on healthy relationships to prevent dating violence and sexual assault.

Our Medical Advocacy Program, "MAP" works to identify and support victims of domestic violence, sexual assault, and human trafficking in healthcare settings across Lackawanna and Susquehanna Counties. SUSQUEHANNA NEWS

In November 2023, WRC's Susquehanna County office moved to a larger, more accessible space, creating a welcoming and comfortable environment for survivors accessing our services. The new office provides enhanced support for those in need.

To mark this milestone, we held an Open House in June 2024, inviting community partners to explore our updated location and learn about the vital services available to survivors in our rural community.

In 2023 and 2024, advocates from both Lackawanna and Susquehanna counties participated in various conferences, including the PCAR statewide conference in July 2023, where our teams from housing, medical advocacy, and the youth prevention program shared insights and strengthened their expertise.

The Susquehanna County WRC office was able to assist

17 adults & 39 children

with safe housing via our Rapid Rehousing Program.

SANTA'S SNIPPERS



Santa's Snippers, a heartwarming haircut-a-thon organized by the WRC Association, was a resounding success, raising an impressive \$9,124. This special event embodied the spirit of giving by offering affordable haircuts to anyone in the community while also providing free haircuts to those in need.

BAG ABUSE

New! Community members took part in the inaugural Bag Abuse fundraiser, held October 4-6 at local grocery stores to raise awareness and funds. Volunteers raised \$8,404 by completing 2-hour shifts at Caravia Fresh Foods, Riccardo's, and various Gerrity's Supermarkets locations.

WRC extends heartfelt thanks to everyone who supported NEPA Gives on June 6th and 7th. Through the collective efforts of individual donors, businesses, and foundations, \$1,243,673 was raised for 200+ local nonprofits, with WRC achieving a remarkable milestone by raising \$15,476 from 75 donors.




50/50 RAFFLE




